Introduction

This 2-in-1 USB-C adapter fully supports IEEE 802.3 standard, compatible with 10/100/1000 Mbps data transmission. The device supports IPv4/IPv6, Wake-on-LAN, automatic switching of full and half duplex and flow control. It also offers a USB-C port for charging devices (e.g. notebooks, tablets, etc.) via USB Power Delivery with up to 95W.

Installation

Connect the ALL-NC-1GPD-USBC to the USB-C port of your end device. Then plug a RJ45 Ethernet cable into the RJ45 jack of the ALL-NC-1GPD-USBC.

See installation example:



The USB-C port on the ALL-NC-1GPD-USBC can be used to charge your notebook/tablet on the side, for example. By using the ALL-NC1GPD-USBC, no USB-C port on your end device is lost.
